Hurdles) other than one, two or three I.N.H. flat races or N.H. flat races or a combination of such races and which had been catalogued in the Goffs Arkle National Hunt Sale (in partnership with Defender) of June 10th, 11th and 12th, 2025 and have been declared by Goffs Bloodstock Sales Ltd. as being eligible to enter and run in accordance with the relevant Conditions of Sale. Horses which do not have a registered name and have not been recorded as Racing Active with a Licensed Trainer by Wednesday, 25th March, 2026 (or if entered from a Foreign Racing Authority named and recorded with a Licensed Trainer), will be automatically struck out of this race. Riders - Qualified Riders under I.N.H.S. Rules. Allowances to riders under Rule 52 may be claimed in this race. HRI Directive 10 is suspended for the purpose of this race. The IHRB, using their powers under Rule 22 have suspended the appropriate paragraphs of Rules 121 and 122. Should it be necessary to reduce the number of declared runners to the maximum runners or to such a lesser number as may be required the

following procedures shall be applied for the elimination and balloting of horses:

(i) Runners will first be reduced by balloting from among those horses that have not run in an INH Flat race, a N.H. Flat race, a Hurdle race or a Point-to-Point Steeplechase in Ireland or Great Britain prior to Thursday, 23rd April, 2026. (ii) In the event of (i) not achieving the recommended limit, runners will then be reduced by balloting from among those horses that have not been placed first, second, third, fourth or fifth in an INH Flat race or N.H. Flat race, first, second, third, fourth or fifth in a Hurdle race or first, second, third or fourth in a Point-to-Point Steeplechase in Ireland or Great Britain prior to 23rd April, 2026, with the order of elimination at the discretion of the N.H. Handicapper.

(iii) In the event of (ii) not achieving the recommended limit, the elimination of the remaining runners will be at the discretion of the N.H.

Handicapper. The Handicapper's decision shall be final.

(International performances will be taken into account and the latest date for assessment will be 10 am Thursday 23rd April 2026).

All entry & forfeit fees will be refunded to the owners of those horses that are eliminated from this race.

The winning Owner will receive a trophy of no intrinsic value presented by Goffs Bloodstock Sales Ltd. Goffs/Defender will present €130 to the groom in charge of the best turned out horse in this race.
